

Terms of Reference for a Special Report

Follow-up on the Board's Experience with Forestry, Range and Water Users

The Forest Practices Board (the Board) has investigated and audited many cases where the public is concerned about the impact of forest and range activities on water resources. In 2011, the Board published its special report *The Forest Practices Board Experience with Forestry and Water Users* (the 2011 report). It has been almost ten years since the Board reported out on domestic water issues, and it continues to receive a high number of domestic water-related complaints. The Board has seen issues related to water quality in its special reports and audits. This report will examine what the Board has found over time in its investigations, audits, and special reports related to water resources, and summarize what actions should be taken to make improvements.

BACKGROUND

The 2011 report summarized the Board's experience under the *Forest Practices Code* and *Forest and Range Practices Act* (FRPA) with forestry and water users to inform government's review of the *Water Act.* The report was based upon some 30 complaints from people who draw consumptive or irrigation water from forested public lands, and from several Board audits that examined the protection of water during forest and range activities.

The Board expressed hope that the (then) proposed *Water Sustainability Act* (WSA) would include measures to help address the recurring issues observed by the Board. The Board suggested that government should help to ensure water users have realistic expectations about the rights their tenures convey, water users should have strengthened involvement and influence in resource use activities in and about sources of domestic water; and that government decision makers may need to step in and mediate where conflicts persist.

In 2014 the WSA replaced the *Water Act* as the primary law for managing the public's water resources. Water-related provisions in FRPA remain unchanged since FRPA was enacted, and the *Drinking Water Protection Act* (DWPA) is still in effect. FRPA, WSA, and DWPA all include mechanisms to address risks to water quality.

The Board has published a total of 28 complaint investigation reports on water-related issues, 3 audit reports specific to water management, and a special investigation of community watersheds. The Board recently published a special report on Fish Habitat that revealed concerns around water quality (https://www.bcfpb.ca/reports-publications/reports/special-investigation-conserving-fish-habitat-under-frpa-part-2/). Yet, the Board continues to receive a high number of public complaints regarding water.

OBJECTIVE

This special report will examine the public complaints investigated by the Board, audits carried out, and special investigations completed under the FRPA regime related to water resources in BC forests. It will summarize the issues identified in its experience, and suggest actions that could be taken to improve on the recurring issues.

The following questions will form the basis of the report:

- What are the top issues the Forest Practices Board has identified related to forest and range practices and water resources?
- What actions can be taken to improve upon the top issues the Board has identified?

SCOPE

The findings and any recommendations coming from domestic water, and other relevant, waterrelated investigations of the Board since FRPA came into effect (see attached list of reports).

APPROACH

This special report will be prepared by:

- 1. Reviewing relevant water related audits and investigations since 2005, tracking issues identified in each report by theme. Themes to be determined by the investigator based on issues found.
- 2. Ranking the themes based on how often they have been identified by the Board.
- 3. Determining whether the top themes have changed since the 2011 report.
- 4. Determining what tools exist in legislation, policy, and guidance to potentially address these issues.
 - ➢ Include FRPA, WSA, DWPA
- 5. Determining what concrete actions can be taken by licensees, water users, or government to improve upon the top themes.
 - Discuss with Board staff
 - Potentially interview officials responsible for the implementation of FRPA, WSA, and DWPA to understand whether the legal or policy tools are being used, and the outcome of their application.
- 6. The Board will conclude on what actions can be taken immediately, and what more is needed to address the concerns of domestic water-users in BC.

REPORTING

The results will be reported to the public. Opportunities for improvement may be identified related to improving the protection or management of the water value under FRPA.
