Dear Kevin Kriese:

On behalf of the Ministry of Forests, Lands, Natural Resource Operations and Rural Development (FLNRORD), I ask you to please accept this letter as government's response to the Forest Practices Board's recommendations in its report *Management of Biodiversity in the Prince George Timber Supply Area (December 2020)*.

As the Forest Practices Board is aware, FLNRORD is currently in the process of responding to the *Strategic Review of How British Columbia Manages for Old Forests Within its Ancient Ecosystems (September 2020)*. This operational response is within the context of that ongoing review. In addition, FLNRORD is in the process of moving forward with Modernized Land Use Planning and it is anticipated that future planning will refine the interim spatialization described in this response.

Forest Practices Board Report Recommendation 1:

Promptly spatialize old growth management areas where the immediate risks to old forest are the greatest.

Government Response:

FLNRORD recognizes the findings of the investigation and has initiated work with First Nations in the Timber Supply Area to develop an interim spatialization approach to the implementation of the *Order Establishing Landscape Biodiversity Objectives for the Prince George Timber Supply Area October 20, 2004* (the "Order"). A spatialized approach to the implementation of the Order will be consistent with the old forest retention objectives defined within the Order.

Key Components:

- FLNRORD's intent is to develop a spatialization approach for the entire Prince George Timber Supply Area. Priority for spatialization would be given to areas of greatest ecological risk.

- A spatialized approach will be interim, with an anticipated duration of 2-3 years. The reason for this interim approach is to promptly respond to the Forest Practices Board and preserve options for longer-term approaches to old growth that would be determined through land use planning.
- Implementation of spatialization may be sequenced to occur in different parts of the Timber Supply Area at different times to manage relationships and existing collaborative processes.
- Implementation of any interim spatial approach will be implemented either through agreement with forest licence holders and First Nations or enforced through the discretion of District Managers.

Forest Practices Board Report Recommendation 2:

Review and update the requirements for biodiversity in the PG TSA. This should be consistent with emerging partnerships with First Nations, following a transparent process for public involvement and considering the potential implications of climate change on forest management.

Government Response:

Determination of a long-term approach to old growth in this area is most appropriately undertaken through land use planning, which is the preferred process mechanism to determine the social, cultural, economic, and environmental trade-offs associated with different approaches. Land use planning in a significant portion of the Prince George TSA is in the early stages and old growth is a primary value under consideration. Interim protection of spatial old growth areas is under active development. Long term protection will come through a finalized land use plan anticipated once a broad public process has been completed.

In closing, I would like to again thank the Forest Practices for its report and recommendations on biodiversity in the PG Timber Supply Area. The ministry looks forward to continued engagement with the Forest Practices Board on how to protect old-growth values as well as practices for the implementation of the modernized land use planning for the protection of ecological values while recognizing communities, residents and Indigenous Nations.

On behalf of the Ministry of Forests (FOR), please accept this letter as a progress update from our initial response (May 27th, 2021) which outlined our commitments to address the Forest Practices Board's recommendations from its report *Management of Biodiversity in the Prince George Timber Supply Area (December 2020)*.

Forest Practices Board Report Recommendation 1:

Promptly spatialize old growth management areas where the immediate risks to old forest are the greatest.

Government Response:

The FOR has completed the spatialization of candidate old forest areas (COFAs) within the Prince George Forest District. The design of the COFAs was a joint collaboration between the FOR and the Ministry of Water, Land and Resource Stewardship (WLRS) and a multi-valued approach was used that combined the best available information and the interests of First Nations. Refinement of the COFAs was done collaboratively with First Nations, BCTS and major forest licensees. Implementation of the Order will be under the direction of a District Managers' Letter of Expectation (DMs LOE), which outlines a management strategy and background information supporting the identification of the COFAs (see attached letter of expectation dated December 21, 2022). The spatial COFAs are considered non-legal Old Growth Management Areas and will be publicly available on the [BC geographic warehouse \(BCGW\)](#). The DMs' LOE is posted on the Order's website ([Prince George TSA Landscape Biodiversity Order - Province of British Columbia \(gov.bc.ca\)](#)).

The Order governs the entire Prince George Timber Supply Area (PG TSA), which includes a portion of the Prince George Forest District and the Stuart Nechako Forest District. However, a phased approach to spatialization has been taken. The Environmental Stewardship Initiative (ESI) with the Carrier Sekani First Nations (CSFN) occupies portions of the Prince George Forest District and much of the Stuart Nechako Forest District. To honour the work occurring with the CSFN, the ESI area was excluded from this spatialization process in this phase of the project. Management of the Order within the Stuart Nechako Forest District and the CSFN ESI study area will continue to be managed non-spatially according to the DMs LOE. Within the Prince George Forest District, the mBEC A04, a landscape unit in the Order, was also excluded from spatialization as there is an approved 2012 spatial recruitment strategy in place to manage the old forest targets under the Order.

Forest Practices Board Report Recommendation 2:


Review and update the requirements for biodiversity in the PG TSA. This should be consistent with emerging partnerships with First Nations, following a transparent process for public involvement and considering the potential implications of climate change on forest management.

Government Response:

Efforts to advance land use planning within the CSFN ESI area is ongoing. Old growth and biodiversity are a primary value under consideration. Additionally, the Province continues to engage with First Nations through government-to-government forums on a new vision for collaborative forest management. This commitment to long term partnerships with First Nations along with broader strategic provincial initiatives, such as the *Old Growth Strategic Review*, are anticipated to clearly define our long-term goals and objectives for our forests.

I trust this letter provides the Forest Practices Board sufficient details into the work we have and continue to undertake to address your concerns. I commit to providing a subsequent update within the next year, outlining our progress with further spatializing the Order and any related land use and or forest landscape planning initiatives.
